## 3B. Project Description

1. Provide a description that addresses the entire scope of the proposed project.

Damien Center’s proposed project is a new Permanent Supportive Housing project that will serve 100% chronically homeless individuals and families while also providing wrap around supportive and healthcare resources to help clients engaged in the program. The project will directly address goals outlined in the 2018-2023 Plan to Address Homelessness by providing Permanent Supportive Housing to vulnerable populations, and by expanding and enhancing wraparound service to increase housing stability and prevent returns to homelessness (Strategic Priority 3), discussed further in the next question.

The target population for this program is adults and adult families with HIV positive head of households and those at high risk for HIV that are chronically homeless, and that have been referred to the PSH program through CHIP. We will serve a total of 31 households through this project, 75% of which will be funded through this request and 25% of which (8 units) will be funded through other HOPWA funding (addressing the Housing Bonus Supplement). There is a coordinated process for HOPWA selection, so we will consider both that and the coordinated entry process when selecting clients for the program. Additionally, the City of Indianapolis and CHIP are collaborating to establish pathways for HOPWA participants to transition into PSH projects, and this project has the [potential to serve as one of those pathways. Assistance will be provided at scattered sites. Housing will be available in one bedroom, two bedroom, three-bedroom, or four-bedroom units to support various family sizes. This will include at least five 3-bedroom units to accommodate larger families.

Permanent Supportive Housing Services will include individualized care plans designed to create housing stability and address the clients self- determined goals. These services can include case management, transportation assistance, food pantry access, referrals to in house employment programming, substance abuse treatment, including internal intensive outpatient programming, life skills classes, mental health, harm reduction, legal services, and out-patient health care. In addition to the extensive supportive services offered at Damien (discussed in greater detail later in this proposal), clients engaged in this program will have access to healthcare services to help prevent return to homelessness through Damien Center’s onsite medical clinic. The medical clinic offers primary medical care, HIV specialty care, gender affirming care, psychiatric services, access to HIV prevention services, and an onsite pharmacy. Those who are disabled or chronically ill will be assisted by SOAR trained staff and agencies to begin the process of disability determinations as applicable.

Measurable outcomes will align with those included in area housing plans, including a reduction in the overall length of time that individuals remain homeless to less than 30 days and a reduction in the overall rates of homelessness amongst black individuals. We will contribute to this goal by tracking the length of time from referral to being housed by racial/ethnic demographics. We will also track clients engagement in supportive services as well as their housing status after exiting the program. These metrics will be tracked using internal systems and, depending on funding source, the HMIS system. Each eligible participant will be referred through HMIS and COC to the Housing Assistance Program.

- Housing Navigation. Grant funds can be used to pay staff time necessary to identify safe units and facilitate moves into housing for survivors through emergency transfer(s).
- Technology to make an available unit safe. Grant funds can be used to pay for technology that the individual believes is needed to make the unit safe, including but not limited to doorbell cameras, security systems, phone, and internet service when necessary to support security systems for the unit, etc.
